The first place prize will have the choice of either firearm. The second place prize will receive the remaining firearm.

**Rules:**

1. Raffle tickets are: 1 ticket for \$10.00, 6 raffle tickets for \$50.00 or 13 raffle tickets for \$100.00. (Discounts only apply for tickets purchased together.) All ticket sales are final, no exceptions.

2. There is no limit to the number of tickets any individual may purchase. No prizes will be awarded to unsold tickets.
3. The prize will be new, factory made firearms as described above
4. Winners will be selected by random drawings conducted on December 18th, 2020 at the Corinth Police Department. **YOU NEED NOT BE PRESENT TO WIN.**
5. It is the responsibility of the entrant to know if they may legally purchase a firearm in the State of Texas.
6. You must be at least 21 years of age and a legal resident of the United States to purchase a ticket.
7. Winners must be at least 21 years old to take possession. Prizes are not transferable. The person designated on the ticket must claim the prize.
8. Winner must be a resident of Texas, New Mexico, Oklahoma, Arkansas or Louisiana.
9. The prize will be awarded and transferred at no cost to the winner by Lowell Johnson; a federally licensed gun dealer (FFL). In the event winners need or wish to have the firearm won transferred to their local FFL dealer closer to their residence, shipping and any other additional costs involved with the transfer will be the responsibility of the winner, and arrangement must be made directly with Lowell Johnson.
10. Winner once notified must claim the firearm within 14 days.
11. All Federal Bureau of Alcohol Tobacco and Firearms (BATF) rules apply and by claiming a firearm prize you agree to provide all information necessary for the transfer of the firearm won.
12. The ATF Form 4473 WILL be utilized in the transfer process.
13. Tickets are sold by, and proceeds will benefit, the Corinth Citizens Police Academy Alumni Association (CCPAAA) a Texas non-profit corporation [501(c)3]. Check with your tax accountant to determine if raffle tickets are tax deductible.
14. The winner assumes all liability for their actions involving the prize once they take ownership of the prize. It is the sole responsibility of the winner to learn how to safely and responsibly handle, operate and maintain a firearm. **THE USE OF FIREARMS IS INHERENTLY DANGEROUS.** The winner agrees to indemnify and hold harmless the Corinth Citizens Police Academy Alumni Association and its Board of Directors and Members for any and all damages that may result from improper or irresponsible use of the prize and from any accidents that may result from its use.
15. Winners will be responsible for any applicable Federal, State and local taxes.
16. At no time will CCPAAA take possession of any of the firearms involved in this raffle; winners will receive firearms directly from Lowell Johnson a FFL dealer. All applicable laws apply.
17. CCPAAA limits any and all liability to the purchase price of tickets purchased.
18. CCPAAA, its Board of Directors and members, makes no warranty of the firearms. Winners are to deal directly with the manufacturer or dealer in the event of problems.
19. Tickets are non-refundable, including those where the winner's background check fails to pass.
20. Tickets are not transferrable. The person designated on the ticket must claim the prize.
21. If a winner is unable to pass the background check, the ticket holder forfeits his/her right to win prize.
22. Winners will be notified by telephone, mail or email depending upon the information provided on the entry ticket. It is the responsibility of the ticket purchaser to provide their contact information in a clearly legible and readable manner. If the contact information does not support contacting the winner the ticket will be considered invalid.
23. This raffle is void where prohibited.
24. The drawing will be made from all of the tickets purchased up to the date of the drawing. The winners will be drawn on Tuesday, December 18, 2020.
25. All information collected by CCPAAA shall be used solely by CCPAAA and will not be sold or otherwise shared with any other entities unless legally required to do so. With the exception of providing Lowell Johnson the selected winners necessary information for claiming the prize.
